Young Brilliant Achievers also collaborates with various partners to offer scholarships, mentors, and opportunities for students to excel academically and personally.

The Coach helps participants learn to navigate an unfamiliar environment, and to be competitive in the job market. Education and resources drive economic empowerment outcomes. GROW delivers English as a second language classes, computer training, resume and interview skills, and financial coaching.
