Young Brilliant Achievers provides homework assistance, tutoring, STEM, sports, music, art, and more to students in grades K-12. Young Brilliant Achievers also collaborates with various partners to offer scholarships, mentors, and opportunities for students to excel academically and personally.

4c (Code:) (Expenses \$ 95,464 including grants of \$) (Revenue \$ 62,276) WORKFORCE: The WORKFORCE program is a bilingual workforce development initiative that serves families with a goal to bridge the wealth gap predominantly impacting People of Color. Workshops and coaching focus on upskilling, customer service, financial empowerment, and more! A coaching model is used to support adults with setting financial independence goals. The Coach helps participants learn to navigate an unfamiliar environment, and to be competitive in the job market. Education and resources drive economic empowerment outcomes. The program delivers English as a second language classes, computer training, resume and interview skills, and financial coaching.
